MA (APPLIED PSYCHOLOGY) (MENTAL HEALTH)

Overview

The MA (Applied Psychology) (Mental Health) is a full-time programme running for 12 months.

Exemptions

Students who have already passed a module(s) as part of another programme, may seek exemption from this module(s) and will be required to take another taught Postgraduate Applied Psychology module to the same credit value.

Alternative pathway - MA (Psychology)

Students who pass 40 credits in Part I but fail the placement (and repeat placement if taken) or are deemed unsuitable to undertake a placement may be permitted to complete 20 credits of taught Postgraduate Applied Psychology modules and a 30 credit dissertation and exit the programme with an MA (Psychology) (https://ucc-ie-public.courseleaf.com/ programmes/mapy/).

Postgraduate Diploma in Applied Psychology (Mental Health)

Students who have completed and passed modules to the value of at least 60 credits in Part I and who fail or do not wish to proceed to Part II may opt to exit the programme and be awarded a Postgraduate Diploma in Applied Psychology (Mental Health). On the recommendation of the School, an Examination Board may decide that a dissertation is a borderline pass/fail and may agree to permit the student to make minor corrections to achieve the pass standard (40 or 50 per cent, as detailed in the module description) for the Dissertation within six weeks of the publication of examination results. This option should apply only where examiners are satisfied that the research described in the Dissertation is fundamentally sound and that the fail judgement relates solely to the presentation of the Dissertation.
