MA (PHILOSOPHY)

Overview

NFQ Level 9, Major Award

The MA (Philosophy) is a full-time programme running over 12 months from the date of first registration for the programme, or part-time running over 24 months from the date of first registration.

Exit Award: Postgraduate Certificate in Philosophy (NFQ Level 9, Minor Award)

Students who pass taught modules to the value of at least 30 credits (but less than 60 credits) may opt to exit the programme and be conferred with a Postgraduate Certificate in Philosophy. (https://ucc-ie-public.courseleaf.com/programmes/pcphi/)
