

# MSC (OCCUPATIONAL HEALTH) (ONLINE)

## Overview

The MSc (Occupational Health) is a part-time programme delivered wholly online and runs over 23 months. The programme is designed to provide students, from a range of professional backgrounds, with a flexible yet structured online learning experience.

## Postgraduate Certificate in Occupational Health (NQF Level 9, Minor Award)

A candidate who passes EH6107, EH6109, EH6141 and EH6142 (30 credits) may opt to exit the programme and be conferred with a Postgraduate Certificate in Occupational Health (<https://ucc-ie-public.courseleaf.com/programmes/pcohl/>). A student who subsequently applies to complete the MSc in Occupational Health must do so within 5 years (60 months) from the date of award of the Postgraduate Certificate in Occupational Health.

## Postgraduate Diploma in Occupational Health (NQF Level 9, Major Award)

Upon successful completion and passing of core taught modules to the value of 60 credits, students may opt to exit the programme and be conferred with a Postgraduate Diploma in Occupational Health (<https://ucc-ie-public.courseleaf.com/programmes/pdohl/>). A student who subsequently applies to complete the MSc in Occupational Health must do so within 5 years (60 months) from the date of award of the Postgraduate Diploma in Occupational Health.

- Demonstrate an understanding of a specialised area and develop critical personal reflection of experience to shape future professional practice and development;
- Demonstrate an understanding of the major legal principles relevant to occupational health and safety, employment and the environment.
